BY-LAW 93-2019

A BY-LAW OF THE TOWN OF CARLETON PLACE TO AUTHORIZE THE EXECUTION OF A MEDICAL TIERED RESPONSE AGREEMENT WITH THE CORPORATION OF THE COUNTY OF LANARK TO AUTHORIZE THE OCEAN WAVE FIRE COMPANY TO RESPOND TO CERTAIN EMERGENY CALLS TO ASSIST THE EMERGENCY MEDICAL SERVICE.

WHEREAS Section 5.3 of the Municipal Act, 2001 (S.O. 2001, c.25) authorizes that municipal powers, including municipality's capacity, rights, powers and privileges under Section 9, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise:

AND WHEREAS Section 9 of the Municipal Act, 2001 (S.O. 2001, c.25), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS it is deemed expedient to authorize the execution of an Agreement with the Corporation of the County of Lanark and other Fire Departments within the County to allow for the automatic dispatch of fire personnel to certain emergency calls to assist the Emergency Medical Service (EMS) in accordance with the

AND WHEREAS having one agreement will ensure consistency in response from Fire Departments across the County to medical assist calls;

NOW THEREFORE the Council of the Town of Carleton Place hereby enacts as follows:

- THAT the Mayor and Clerk are hereby authorized to execute on behalf of the Town of Carleton Place a Tiered Response Agreement with the Corporation of the County of Lanark.
- 2. THAT the Clerk shall be and is hereby authorized to affix the corporate seal of the Corporation of the Town of Carleton Place to the said contract.

BY-LAW NO. 94-2019

A BY-LAW OF THE CORPORATION OF THE TOWN OF CARLETON PLACE TO EXEMPT CERTAIN LANDS FROM PART LOT CONTROL, PART OF BLOCK 67, REGISTERED PLAN 27M-73, PARTS 1 TO 5 INCLUSIVE ON PLAN 27R-11320, IN THE TOWN OF CARLETON PLACE, IN THE COUNTY OF LANARK.

WHEREAS Subsection 7 of Section 50 of *The Planning Act*, R.S.O. 1990 as amended, authorizes a Municipality to provide a by-law that part lot control does not apply to land that is within registered plans or plan of subdivision or parts thereof, subject to the approval of the County of Lanark;

AND WHEREAS it is deemed expedient to exempt certain lands located in an area designated Residential in Development Permit By-law 15-2015, and described as Part of Block 67, Registered Plan 27M-73, Parts 1 to 5 inclusive on Plan 27R-11320 in the Town of Carleton Place, in the County of Lanark;

AND WHEREAS *The Planning Act*, subsection 50 (7.1) does not come into effect until approved by the County of Lanark;

NOW THEREFORE the Council of the Corporation of the Town of Carleton Place enacts as follows:

- Subsection 5 of Section 50 of *The Planning Act*, R.S.O. 1990, as amended, does not apply to Part of Block 67, Registered Plan 27M-73, further described as Parts 1 to 5 inclusive on Plan 27R-11320 in the Town of Carleton Place, in the County of Lanark.
- 2. This by-law shall be effective only to the extent necessary to permit;
 - a) The creation of blocks and parcels for construction purposes and to permit such lots to be charged and/or discharged
 - b) Individual dwelling units, together with appurtenant rights and easements in land associated therewith, to be conveyed to each initial purchaser of each individual dwelling unit;
 - And this by-law shall not be construed as to permit the further severance or resubdivision of any such parcel.
- 3. This by-law shall become effective upon the approval of the County of Lanark and registration of the by-law in the land titles office.
- 4. This by-law shall expire and be of no further force and effect as of October 8, 2021.
- 5. The property is locally known as 32 and 34 Matthews Street.

BY-LAW NO. 95-2019

A BY-LAW OF THE CORPORATION OF THE TOWN OF CARLETON PLACE TO EXEMPT CERTAIN LANDS ON RATHWELL STREET AND FANNING STREET ON REGISTERED PLAN 27M-77 IN THE TOWN OF CARLETON PLACE, IN THE COUNTY OF LANARK AS BEING EXEMPT FROM PART LOT CONTROL.

WHEREAS the *Planning Act*, R.S.O. 1990, c.P.13, as amended, (the "*Planning Act*") subsection 50(5) provides that all lands within a plan of subdivision are subject to part lot control:

AND WHEREAS Subsection 7 of Section 50 of *The Planning Act*, R.S.O. 1990 as amended, authorizes a Municipality to provide a by-law that part lot control does not apply to land that is within registered plans or plan of subdivision or parts thereof, subject to the approval of the County of Lanark;

AND WHEREAS it is deemed expedient to exempt certain lands as identified in this Bylaw located on Rathwell Street and Fanning Street on Registered Plan 27M-77 in the Town of Carleton Place, in the County of Lanark;

AND WHEREAS *The Planning Act*, subsection 50 (7.1) does not come into effect until approved by the County of Lanark;

NOW THEREFORE the Council of the Corporation of the Town of Carleton Place enacts as follows:

- 1. Subject to Section 2 hereof, Section 5 of Section 50 of *The Planning Act*, R.S.O. 1990, as amended, does not apply to the lands described as:

- 2. This by-law shall be effective only to the extent necessary to permit:
 - a) The creation of blocks and parcels for construction purposes and to permit such lots to be charged and/or discharged
 - b) Individual dwelling units, together with appurtenant rights and easements in land associated therewith, to be conveyed to each initial purchaser of each individual dwelling unit;
 - And this by-law shall not be construed as to permit the further severance or resubdivision of any such parcel.
- 3. A conveyance or conveyances in favour of the Town of Carleton Place shall not for the purpose of this by-law be considered to be a severance and this by-law shall also be deemed to permit the grant or release of easements held in favour of the Town of Carleton Place on or with respect to the lands described above.
- 4. This by-law shall become effective upon the approval of the County of Lanark and registration of the by-law in the land titles office.
- 5. This by-law shall expire and be of no further force and effect as of October 8, 2021.
