# Recommended Motion:

**THAT** the Council of the Town of Carleton Place supports the Association of Municipalities of Ontario (AMO) in its submission to the Attorney General entitled *"Towards A Reasonable Balance: Addressing growing municipal liability and insurance costs";* and

**THAT** the Town endorses the AMO's recommendations to address these issues as follows:

- 1. The provincial government adopt a model of full proportionate liability to replace joint and several liability.
- 2. Implement enhancements to the existing limitations period including the continued applicability of the existing 10-day rule on slip and fall cases given recent judicial interpretations, and whether a 1-year limitation period may be beneficial.
- 3. Implement a cap for economic loss awards.
- 4. Increase the catastrophic impairment default benefit limit to \$2 million and increase the third-party liability coverage to \$2 million in government regulated automobile insurance plans.
- 5. Assess and implement additional measures which would support lower premiums or alternatives to the provision of insurance services by other entities such as non-profit insurance reciprocals.
- 6. Compel the insurance industry to supply all necessary financial evidence including premiums, claims, and deductible limit changes which support its, and municipal arguments as to the fiscal impact of joint and several liability.
- 7. Establish a provincial and municipal working group to consider the above and put forward recommendations to the Attorney General.

# BY-LAW NO. 97-2019

#### A BY-LAW OF THE CORPORATION OF THE TOWN OF CARLETON PLACE TO AMEND THE SIGN, MERCHANDISE DISPLAY, AND AWNING BY-LAW NO. 65-2008

**WHEREAS**, pursuant to subsection of Section 99 of The Municipal Act, 2001, c. 25 as amended, a municipality may pass by-laws for prohibiting or regulating signs and other advertising devices, may define a class or classes of signs or other advertising devices, and may specify a time period during which signs or other advertising devices in a defined class may stand or be displayed in the municipality, and may require the removal of such signs or other advertising devices which continue to stand or be displayed after such time period has expired;

**AND WHEREAS** the Council of the Town of Carleton Place adopted By-law 65-2008, the Sign, Merchandise Display and Awning By-law;


**AND WHEREAS** it is deemed expedient and necessary to amend By-law 65-2008;

**NOW THEREFORE** the Council of the Corporation of the Town of Carleton Place hereby enacts as follows:

**1.** THAT Schedule B to By-law No. 65-2008 (Sign, Merchandise Display and Awning) be replaced with the attached map.

#### BY-LAW NO. 98-2019

#### A BY-LAW OF THE CORPORATION OF THE TOWN OF CARLETON PLACE TO ESTABLISH AND DEDICATE CERTAIN PORTIONS OR TRACTS OF LAND AS PUBLIC HIGHWAY TO BE KNOWN AS PART OF ARTHUR STREET

**WHEREAS** Section 31(2) of the Municipal Act, S.O. 2001, Chapter 25 as amended authorizes a municipality to establish a public highway;

**AND WHEREAS** Section 4 on RP27R-5391 was transferred to the Town of Carleton Place but was never assumed into the Town's road system;

**NOW THEREFORE** the Council of the Town of Carleton Place enacts as follows:

1. That the portion or tract of land described below is established and dedicated as a public highway:

Lots 130 and 131, Plan 6115 in the Town of Carleton Place, in the County of Lanark, being Part 4 on Plan 27R-5391, to be included as part of Arthur Street.

2. That the Solicitor be hereby authorized to deposit a copy of this By-law on title in the Lanark Land Titles Office No. 27.

#### A BY-LAW OF THE CORPORATION OF THE TOWN OF CARLETON PLACE TO EXEMPT CERTAIN LANDS FROM PART LOT CONTROL, PART OF BLOCK 115, REGISTERED PLAN 27M-77, PARTS 1 TO 10 INCLUSIVE ON PLAN 27R-11326, IN THE TOWN OF CARLETON PLACE, IN THE COUNTY OF LANARK.

**WHEREAS** Subsection 7 of Section 50 of *The Planning Act*, R.S.O. 1990 as amended, authorizes a Municipality to provide a by-law that part lot control does not apply to land that is within registered plans or plan of subdivision or parts thereof, subject to the approval of the County of Lanark;

**AND WHEREAS** it is deemed expedient to exempt certain lands located in an area designated Residential in Development Permit By-law 15-2015, and described as Part of Block 115, Registered Plan 27M-77, Parts 1 to 10 inclusive on Plan 27R-11326 in the Town of Carleton Place, in the County of Lanark;

  - a) The creation of blocks and parcels for construction purposes and to permit such lots to be charged and/or discharged
  - b) Individual dwelling units, together with appurtenant rights and easements in land associated therewith, to be conveyed to each initial purchaser of each individual dwelling unit;

And this by-law shall not be construed as to permit the further severance or resubdivision of any such parcel.

- 3. This by-law shall become effective upon the approval of the County of Lanark and registration of the by-law in the land titles office.
- 4. This by-law shall expire and be of no further force and effect as of October 22, 2021.
- 5. The property is locally known as 72, 74, 76, 78 and 80 Stokes Drive.

# BY-LAW NO. 101-2019

# BEING A BY-LAW TO CONFIRM THE PROCEEDINGS OF THE COUNCIL OF THE CORPORATION OF THE TOWN OF CARLETON PLACE

**WHEREAS** the Municipal Act S.O. 2001, c 25, Section 5(1), as amended, provides that the powers of a municipal corporation are to be exercised by its council;

**AND WHEREAS** the Municipal Act S.O. 2001, c 25, Section 5(3), as amended, provides that a municipal power, including a municipality's capacity rights, powers and privileges under section 9; shall be exercised by by-law;

**AND WHEREAS** the Council for The Corporation of the Town of Carleton Place deems it expedient that the proceedings of meetings of Council be confirmed and adopted by by-law;

**NOW THEREFORE** the Council of the Corporation of the Town of Carleton Place enacts as follows:

- That the actions of the Council of the Corporation of the Town of Carleton Place at its meeting held on October 22, 2019, in respect to each report, motion, resolution or other actions recorded and taken by the Council at its said meeting, except where the prior approval of the Ontario Municipal Board is required, is hereby adopted, ratified and confirmed as if all such proceedings were expressly embodied in this by-law;
- 2. That the Mayor and appropriate Manager of the Corporation are hereby authorized and directed to do all things necessary to give effect to the said actions of the Council of the Town of Carleton Place referred to in the proceeding section;
- 3. That the Mayor and Clerk, and their designates, are hereby authorized and directed to execute all documents necessary on behalf of the Council and to affix the corporate seal of the Corporation of the Town of Carleton Place to all such documents;
- 4. That the Treasurer, or designate, is hereby directed to execute any documents necessary on behalf of the Council of the Town of Carleton Place and to affix the corporate seal of the municipality to all such documents.
- 5. That this by-law shall come into effect upon final passage.
- 6. This by-law may be cited as the "October 22, 2019 Confirmatory By-Law"
