## Physical Environment

1. Transition to Full Producer Responsibility for Blue Box Services (Communication 131068)

#### **Recommended Motion:**

WHEREAS the amount of single-use plastics leaking into our lakes, rivers, waterways is a growing area of public concern;

AND WHEREAS reducing the waste we generate and reincorporating valuable resources from our waste stream into new goods can reduce GHGs significantly;

AND WHEREAS the transition to full producer responsibility for packaging, paper and paper products is critical to reducing waste, improving recycling and driving better economic and environmental outcomes:

AND WHEREAS the move to a circular economy is a global movement, and the transition of Blue Box programs would go a long way towards this outcome:

AND WHEREAS the Town of Carleton Place is supportive of a timely, seamless and successful transition of Blue Box programs to full financial and operational responsibility by producers of packaging, paper and paper products;

AND WHEREAS the Association of Municipalities of Ontario has requested municipal governments with Blue Box programs to provide an indication of the best date to transition our Blue Box program to full producer responsibility;

NOW THEREFORE BE IT RESOLVED THAT the Town of Carleton Place would like to transition their Blue Box program to full producer responsibility on January 1, 2023;

AND this decision is based on the following rationale:

The Town of Carleton Place recently entered into a contract for recyclable material collection and processing with the term of the contract expiring on January 1, 2023. The new contract incorporated a significant increase in cost for these services which should not be the burden of the Town's residents but of producers;

AND the Town of Carleton Place would be interested in providing

collection services to Producers should we be able to arrive at mutually agreeable commercial terms;

AND FURTHER THAT any questions regarding this resolution can be directed to Dave Young, Director of Public Works, at dyoung@carletonplace.ca;

AND THAT this Resolution be forwarded to the Honorable Jeff Yurek, Minister of Environment, Conservation, and Parks, and to Jamie McGarvey, President of the Association of Municipalities of Ontario.

## **BY-LAW NO. 53-2020**

A BY-LAW OF THE CORPORATION OF THE TOWN OF CARLETON PLACE TO AUTHORIZE THE SIGNING OF A CONTRIBUTION AGREEMENT BETWEEN HER MAJESTY THE QUEEN IN RIGHT OF ONTARIO AS REPRESENTED BY THE MINISTER OF AGRICULTURE FOOD AND RURAL AFFAIRS AND THE CORPORATION OF THE TOWN OF CARLETON PLACE FOR RECEIPT OF FUNDING UNDER THE RURAL ECONOMIC DEVELOPMENT (RED) PROGRAM TOWARDS DOWNTOWN REVITALIZATION LANDSCAPING AND STREETSCAPING ELEMENTS.

**WHEREAS** Section 5.3 of the Municipal Act, 2001 (S.O. 2001, c.25) authorizes that municipal powers, including municipality's capacity, rights, powers and privileges under Section 9, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise:

**AND WHEREAS** Section 9 of the Municipal Act, 2001 (S.O. 2001, c.25), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

**WHEREAS** Section 22 of the Municipal Act, 2001 (S.O. 2001, c.25), authorizes a municipality to provide a system that it would otherwise not have power to provide within a municipality, if it does so in accordance with an agreement with the Province of Ontario under a program established and administered by the Province of Ontario;

**AND WHEREAS** the Council of the Town of Carleton Place deems it expedient to enter into an agreement with Her Majesty the Queen in Right of Ontario as represented by the Minister of Agriculture, Food and Rural Affairs to provide \$83,340.00 towards downtown revitalization landscaping and streetscaping elements;

**NOW THEREFORE** the Council of the Corporation of the Town of Carleton Place enacts as follows:

## 1. SHORT TITLE

This By-Law is short titled "Rural Economic Development Grant – Downtown Revitalization".

### 2. **AGREEMENT**

- (a) THAT the Mayor and Clerk shall be and are hereby authorized on behalf of the Corporation of the Town of Carleton Place to enter into a contribution agreement between the Corporation of the Town of Carleton Place and Her Majesty the Queen in Right of Ontario as represented by the Minister of Agriculture, Food and Rural Affairs to provide \$83,340.00 in funding under Rural Economic Development Program.
- (b) **THAT** the Clerk shall be and is hereby authorized to affix the corporate seal of the Corporation of the Town of Carleton Place to the said agreement.

#### **BY-LAW NO. 54-2020**

A BY-LAW OF THE CORPORATION OF THE TOWN OF CARLETON PLACE TO AMEND BY-LAW NO. 120-2019 TO ESTABLISH FEES AND CHARGES FOR SERVICES PROVIDED BY THE TOWN AND SPECIFICALLY FOR THE PLANNING DEPARTMENT.

**WHEREAS** Section 391 of the *Municipal Act*, 2001, S. O. 2001, c. 25, as amended, authorizes a municipality by by-law to impose fees or charges on persons for services or activities provided or done by or on behalf of the municipality and for the use of the municipality's property; and

**WHEREAS** Section 69 (1) of the *Planning Act*, being Chapter P. 13 R.S.O., 1990 as amended, provides that Council may prescribe a tariff of fees for the processing of applications made in respect of planning matters; and

**WHEREAS** the Corporation of the Town of Carleton Place deems it expedient to update the fees and charges to be collected by the various departments of the Corporation of the Town of Carleton Place by adding a provision for the recovery of costs incurred by the Town for the provision of consultations at various stages of the Development Permit Application process;

**NOW THEREFORE** the Council of the Corporation of the Town of Carleton Place enacts as follows:

- 1. That Schedule "A" to By-law 120-2019 be amended by adding the following provision under the General Heading of the Planning Development-Related Fees and Charges Section:
  - Additional consultation meetings (in person, by phone or email) as follows at a cost of \$50.00/per hour, min ½ hour fee for recovery of costs:
    - Pre-consult Stage: two (2) pre-consults; charges begin after second pre-consult
    - Application/Circulation Stage: four (4) consultations; charges begin after fourth consult
    - Drafting of Agreement Stage: two (2) consultations; charges begin after second consult"
- 2. That this by-law shall come into force and take effect on the date of passing of this By-law.

#### BY-LAW NO. 55-2020

A BY-LAW OF THE CORPORATION OF THE TOWN OF CARLETON PLACE TO REMOVE ONE-FOOT RESERVES LEGALLY DESCRIBED AS BLOCK 128, BLOCK 129, BLOCK 130 AND BLOCK 131 ON PLAN 27M-77 AND TO DEDICATE SAID RESERVES AS A PUBLIC HIGHWAY, AS PART OF FANNING STREET, STANZEL DRIVE AND RATHWELL STREET

**WHEREAS** a one-foot reserve was retained by the Corporation of the Town of Carleton Place at Block 128, at Block 129, at Block 130 and at Block 131 on Plan 27M-77 in the Town of Carleton Place;

**AND WHEREAS** the retention of the above-noted one-foot reserves are deemed no longer necessary;

**NOW THEREFORE** the Council of the Corporation of the Town of Carleton Place enacts as follows:

- 1. **THAT** Block 128 on Plan 27M-77 be hereby dedicated as a public highway, as part of Fanning Street.
- 2. **THAT** Block 129 on Plan 27M-77 be hereby dedicated as a public highway, as part of Stanzel Drive.
- 3. **THAT** Block 130 on Plan 27M-77 be hereby dedicated as a public highway, as part of Stanzel Drive.
- 4. **THAT** Block 131 on Plan 27M-77 be hereby dedicated as a public highway, as part of Rathwell Street.
- 5. **THAT** a copy of this By-law be deposited on title in the Lanark Land Titles Division Office No. 27.

#### **BY-LAW NO. 56-2020**

A BY-LAW OF THE CORPORATION OF THE TOWN OF CARLETON PLACE TO REPEAL BY-LAW 35-2019 BEING A BY-LAW TO PROVIDE FOR THE MAKING OF AN APPLICATION FOR APPROVAL TO EXPROPRIATE LANDS AT COLEMAN STREET AND LANSDOWNE AVENUE IN THE TOWN OF CARLETON PLACE.

**WHEREAS** the Town of Carleton Place has determined that it no longer requires all right title and interest (fee simple) in the lands described in Schedules "A" and "B" attached hereto (the "Lands") for municipal purposes;

**AND WHEREAS** pursuant to Section 6(1) of the *Municipal Act, 2001, S.O. 2001*, c. 25, as amended, the power of a municipality to acquire land under this or any other Act includes the power to expropriate in accordance with the *Expropriations Act*, R.S.O. 1990, c.E.26, as amended (hereinafter referred to as the "*Expropriations Act*");

**AND WHEREAS** pursuant to Section 4 of the *Expropriations Act*, an expropriating authority, in this case, the Town of Carleton Place, shall not expropriate land without the approval of the approving authority, in this case, the Council of the Town of Carleton Place;

**NOW THEREFORE** the Council of the Corporation of the Town of Carleton Place hereby enacts as follows:

- 1. The Council of the Town of Carleton Place hereby repeals By-law 35-2019 which approved the making of an application for approval to expropriate land in the Town of Carleton Place as described in Schedule "A" and Schedule "B", appended hereto.
- 2. This By-law shall take effect on its passing.



## **BY-LAW NO. 57-2020**

## BEING A BY-LAW TO CONFIRM THE PROCEEDINGS OF THE COUNCIL OF THE CORPORATION OF THE TOWN OF CARLETON PLACE

**WHEREAS** the Municipal Act S.O. 2001, c 25, Section 5(1), as amended, provides that the powers of a municipal corporation are to be exercised by its council;

**AND WHEREAS** the Municipal Act S.O. 2001, c 25, Section 5(3), as amended, provides that a municipal power, including a municipality's capacity rights, powers and privileges under section 9: shall be exercised by by-law:

**AND WHEREAS** the Council for The Corporation of the Town of Carleton Place deems it expedient that the proceedings of meetings of Council be confirmed and adopted by by-law;

**NOW THEREFORE** the Council of the Corporation of the Town of Carleton Place enacts as follows:

- That the actions of the Council of the Corporation of the Town of Carleton Place at its meeting held on **June 9, 2020**, in respect to each report, motion, resolution or other actions recorded and taken by the Council at its said meeting, except where the prior approval of the Ontario Municipal Board is required, is hereby adopted, ratified and confirmed as if all such proceedings were expressly embodied in this by-law;
- That the Mayor and appropriate Manager of the Corporation are hereby authorized and directed to do all things necessary to give effect to the said actions of the Council of the Town of Carleton Place referred to in the proceeding section;
- 3. That the Mayor and Clerk, and their designates, are hereby authorized and directed to execute all documents necessary on behalf of the Council and to affix the corporate seal of the Corporation of the Town of Carleton Place to all such documents;
- 4. That the Treasurer, or designate, is hereby directed to execute any documents necessary on behalf of the Council of the Town of Carleton Place and to affix the corporate seal of the municipality to all such documents.
- 5. That this by-law shall come into effect upon final passage.
- 6. This by-law may be cited as the "June 9, 2020 Confirmatory By-Law"
