Enforcement (MLES) – 2024 4th Quarter Activity Report

SUMMARY

The fourth quarter activity reports for the Carleton Place Fire Department and Municipal Law Enforcement are attached.

COMMENT

Items of note for Q4 include:

Carleton Place Fire Department (CPFD)

- Fire Prevention Week held October 6-12, 2024 was a success. This year's theme
 was Smoke alarms: Make them work for you!
- As always, CPFD was proud to participate in Carleton Place's annual Christmas Parade.
- The final numbers revealed that between fire prevention events, training, and fire calls, CPFD had a record year, with 298 calls.

Municipal Law Enforcement

- Over 800 winter parking warnings were issued from November 15, 2024- December 31, 2024. Municipal Law Enforcement staff took an educational approach to winter parking issues this quarter, which received a very good response, ultimately resulting in fewer parking tickets.
- Incident report investigations were up this year, reflecting an increase in complaints from past years. These investigations are often private property related issues such as illegal dumping, long grass in yards, and hazardous trees.

Emergency Management

- The annual Tabletop Emergency Exercise was held in October. The scenario tested the Town response to a mock cybersecurity breach.
- Staff completed and submitted the annual compliance report to Emergency Management Ontario (EMO).
