

**BY-LAW NO. 07-2025**

**A BY-LAW OF THE CORPORATION OF THE TOWN OF CARLETON PLACE TO AUTHORIZE THE SIGNING OF A CONTRIBUTION AGREEMENT BETWEEN HIS MAJESTY THE KING IN RIGHT OF ONTARIO AS REPRESENTED BY THE MINISTER OF INFRASTRUCTURE AND THE CORPORATION OF THE TOWN OF CARLETON PLACE FOR RECEIPT OF FUNDING UNDER THE HOUSING-ENABLING CORE SERVICES FUND TOWARDS THE CONSTRUCTION OF CAPTAIN A. ROY BROWN BOULEVARD (CARBB) INCLUDING TRAFFIC LIGHTS AT THE INTERSECTION OF CARBB AND HIGHWAY 15.**

**WHEREAS** Section 5.3 of the Municipal Act, 2001 (S.O. 2001, c.25) authorizes that municipal powers, including municipality's capacity, rights, powers and privileges under Section 9, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise;

**AND WHEREAS** Section 9 of the Municipal Act, 2001 (S.O. 2001, c.25), provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

**WHEREAS** Section 22 of the Municipal Act, 2001 (S.O. 2001, c.25), authorizes a municipality to provide a system that it would otherwise not have power to provide within a municipality, if it does so in accordance with an agreement with the Province of Ontario under a program established and administered by the Province of Ontario;

**AND WHEREAS** the Council of the Town of Carleton Place deems it expedient to enter into a Transfer Payment Agreement with His Majesty the King in Right of Ontario as represented by the Minister of Infrastructure to provide \$7,359,375 towards the construction of Captain A. Roy Brown Boulevard (CARBB) including traffic lights at the intersection of CARBB and Highway 15;

**NOW THEREFORE** the Council of the Corporation of the Town of Carleton Place enacts as follows:

1. **SHORT TITLE**

This By-Law is short titled "Housing-Enabling Core Services Fund".

2. **AGREEMENT**

(a) **THAT** the Mayor and CAO/Deputy Clerk shall be and are hereby authorized on behalf of the Corporation of the Town of Carleton Place to enter into a contribution agreement between the Corporation of the Town of Carleton Place and His Majesty the King in Right of Ontario as represented by the Minister of Infrastructure to provide \$7,359,375 in funding to the Town under the Housing-Enabling Core Services Fund.

(b) **THAT** the Clerk shall be and is hereby authorized to affix the corporate seal of the Corporation of the Town of Carleton Place to the said agreement.
